## **IMPORTANT DATA PROTECTION INFORMATION**

### **PLEASE READ CAREFULLY**

In May 2018 a new Data Protection Act became law in the U.K. and is now known as The General Data Protection Regulation, or GDPR. As a holder and processor of personal information the parish must comply with the GDPR. The regulation protects all individuals' personal information from being used for anything other than its intended and legitimate use. Individuals are entitled to know what personal information is being held, how it is being used and to have it removed if they wish. There are certain legal requirements upon organisations to make known how it uses information and how it is stored and protected. To this end, the parish has recently reviewed the regulations and has published two important documents on the parish website. Hard copies of these documents are available if required. Please see our contact details below.

The documents cover:

- The GDPR Generic Regulations,
- The Parish Privacy Notice

These documents explain what information is legally held, how it is used and how it is stored securely.

In particular the Parish Privacy Notice contains information about the following:

1. Your personal data – what is it?
2. Who are we? i.e. The Parish & Diocese
3. How we process your personal data.

4. What is the legal basis for processing your personal data?
5. Sharing your personal data.
6. How long we keep your personal data.
7. Your rights
8. Further processing of data.
9. What we must do if we wish to use your personal data for a new purpose

### **Social Media**

The GDPR also covers individual privacy when using an organisations social media account, for example WhatsApp. As we have a well-established parish WhatsApp group, it is essential that individual entries, **personal data and contact details must not be shared** with any third party outside of the parish WhatsApp group without the explicit consent of the individual/s the information relates to.
